




RIA vs. ERA

Respondents by RIA vs. ERA




Firm Became RIA in 2016 or Examined by SEC in 2016?






Firm Headcount

Assets Under Management




Firm AUM Details (\$M)




Geographic Spread



Firm's Compliance Responsibilities are Handled...








Total Annual Compliance Cost for Most Recent Fiscal Year (2016)


Breakdown of Overall Compliance Costs for All Respondents by Type




Approx. Annual Cost (\$) of Compliance with RIA Requirements for Most Recent Fiscal Year Completed (2016)




Compliance Cost as % of Management Company's Operating Expenses for Most Recent Fiscal Year Completed (2016)

Firm's Total Management Fees (\$M) for Most Recent Fiscal Year Completed (2016)




Compliance Cost as % of Management Fees


Top Three Most Costly Compliance Issues for ERAs, Ranked 1-3


Top Three Most Costly Compliance Issues for RIAs, Ranked 1-3






ERAs' Compliance \$ Expectations

ERAs' Anticipated Compliance Cost Change for Current Fiscal Year (2017)




RIAs' Anticipated Compliance Cost Change for Current Fiscal Year (2017)






Firm Received Requests from Investors for Specific Compliance-related Policies & Activities?



...If Yes, Has Your Firm Developed Templates to Deal with These Requests?




Is Regulatory Compliance Explicitly Defined as a Partnership Expense in Your LPA?












Total Financial Reporting Costs for Most Recent Fiscal Year (2016)


Breakdown of Overall Financial Reporting Costs for All Respondents by Type


Median & Average Financial Reporting Cost (\$) Breakdown for ERAs










Financial Statement Audit & Tax Return Costs




Cost Associated w/Audit of Financial Statements

Management Company Audited?




Audit Cost (\$) for Most Recent Fiscal Year Completed (2016)






Costs Associated with Audit

Anticipated Changed in Costs Related to Fund's Audit for the Current Fiscal Year (2017)






Costs Associated with Tax
